- 1) Confirmation Resolved that the Minutes of the 1st meeting of the 10th Executive Council held on 6.12.2020 at 11.00 am on virtual mode, copy of which had been circulated in Annexure "A" to the agenda, are hereby confirmed.
- 2) Considered the finalisation of issues regarding 2020 convocation.

The matter is discussed in the meeting and it is resolved that

- a) Degrees be awarded on 24^{th} December, 2020 without holding Convocation as per Govt. of West Bengal notification No. 174L/OM-115L/2020 Dated 10.12.2020 (Annexure -1).
- b) Certificate be made as per Annexure -II.
- c) Certificates be uploaded in the University website and certificates be made available through Student Portal.
- d) Hard copies of the certificates would be mailed to the students. For this purpose a Website Notification will be issued requesting the students to send their mailing addresses.
- e) However, students urgently requiring hard copies of certificates can collect them from the office of Controller of Examinations from after making prior appointments. The modalities of the distribution of certificates in such cases will be decided by the Controller of Examinations maintaining all public health precautions in view of the current pandemic.

The above resolution be confirmed and approved for immediate action.

- Noted the letter dated 13:12.2020 of Prof. Chiranjib Bhattacharjee. All members thanked Prof. Chiranjib Bhattacharjee for his great support to upgrade the ERP Cell.
