**On considering the deputation** made by the students of FETSU, SFSU & AFSU, it was reported by the Pro.Vice-Chancellor (Dr. Chiranjib Bhattacharyya) that the hard copies of all the final year Grade Card (i.e. B.A., B.Ss., B.E, M.Sc., M.A., M.E & M. Phil) will be available on the week commencing from 19<sup>th</sup> August,2019. It was further reported by the Pro-Vice-Chancellor (CB) after consultation with the Assistant Controller of Examinations that remaining result, i.e. M.A. Repeat, M.Phil Repeat, B.E. Repeat, B.E. 2<sup>nd</sup> Year, B.E. 1<sup>st</sup> Year, B.Sc. and P.G-I Engineering will be published consequential one after another as soon as possible.

It was reported by the Vice-Chancellor that the Government Order regarding increase of seats from 100 to 131 has already been received by the University.
