"Members of the Doctorate Committee (Arts) discussed in detail the difficulties faced in the various Departments over the issue of suitable expertise for the examination of thesis for the Ph. D degree in the faculty. It was felt that the existing rules debarring the external members of the Board of Studies and the Examination Committee of the different Departments and the teachers who have retired from the services of the University may be revisited. Without the possible involvement of these experts, it is becoming difficult to prepare the list of examiners in several cases. There is no reason for not availing the available expertise and resources as and when needed. Accordingly, the Committee recommends that the existing rule in this respect5 may be suitably modified to allow for possible involvement of scholars/experts in the examination process of the Ph.D. thesis under the faculty.

Members also felt that the University must involve outside experts in the Research Advisory Committees in respect of Ph.D. candidates enrolled since 2017. The current emphasis to discourage experts form outside the University to serve the RAC is not justified on academic grounds. Keeping in view the resource crunch, it was agreed, however that RACs may not involve experts from outside West Bengal. However, there should not be a bar on involving experts form within West Bengal."
